of Brushy creek waters of Enoree river Beginning at a red oak st. da for Joseph
McAfee & George Ross thence on said line S. 68. 20. 9. to a Stake st. thence N. 22. W. 2. to a
Holly st. on the bank of a small branch thence up the meanders of said
branch to a B. Gum st. thence S. 68. 16. 11. 50. to a Hickory st. thence S. 40. E. 16. 50. to a
Post oak st. on. for Thomas Threlkeld thence on S. line N. 70. E. 2. to a Stake st. thence S. 40
E. 2. 50. to a red oak st. thence S. 75. E. 3. 50. to a red oak st. thence N. 31. E. 11. to a Sowruss st.
on the bank of sd Creek, then up the meanders of said Creek to the Beginning, which
includes the ^{whole of the} land to be conveyed by the same man or left Together with all and
