


Plantation and tract of Land which he now liveth, Beginning on a Red oak
 the corner of a tract of Land granted to the said John Gowen Senr. in the year one
 thousand seven hundred and ninety three Feb. the fourth. from thence S. W. 23 Ch.
 to a red oak S. 35. E. 2:30 to a red oak thence S. 62 W. 28 to a Spanish oak on the bank
 of the River thence up the river nearly to the crops fence in a bend of the river, from
 thence to a large poplar then by an agreed line through the field to a small
 Hickory sapling thence on the same course till it strikes the original line of said
 tract thence to the beginning. Containing ninety five acres be the same more or less
 being part of a tract granted to the said John Gowen in the year of our Lord one
 thousand seven hundred and Eighty four, lying being in the State and district
 of Greenville. which said land I do hereby warrant for myself my
 heirs &c. to the said Jesse Mayfield his heirs and assigns forever, against all manner
 of persons lawfully claiming any part thereof. Witness my hand and Seal
 this twentieth day of October A.D. Eighteen hundred & seven and of the independ-
 -ence of America the thirty second year. Signed in presence of us

State of South Carolina Greenville County. Know all men by these presents that
 I James Howell of the State & County aforesaid, for and in consideration of ten pounds
current money to me in hand paid by Abner Howell and Levi Howell of the County &
 State aforesaid, have granted bargained sold and released, and by these presents do grant
 bargain sell and release unto the said Abner Howell and Levi Howell of the County &
 State aforesaid, all that tract of Land lying in Greenville County containing two
 hundred acres more or less being part of a tract granted to John Timmons by his
 Excellency Benj. Guinard Esq. then governor of this State, and conveyed by said
 Timmons to James Howell as by grant and deed will more fully appear —
 it being the said land that Howell now lives on joining land surveyed for David Goodlett
 and James Ritchey and the said land to be equally divided between Abner Howell and
 Levi Howell as follows, Beginning on David Goodlett's corner near the head of my spring
 branch running through the plantation to a line made by Elias Eakle & David Goodlett
 so as to divide the said land equally between Abner Howell & Levi Howell —
