 all water and water Courses Timber and profits and Enclosures or any part
 thereof with all and singular the issues and profits, Hereditaments, incident
 or any wise appertaining to the 2^d two hundred acres more or less and further the
 3^d John Battson does covenant with the said Elliott Clardy and does warrant and
 forever defend the above mentioned premises aforesaid from himself his heirs Executors and
 every other person or persons Lawfully claiming or to claim the same or any part thereof
