TO all whom it may concern KNOW Ye that I Benjamin Arnold of Greenville District & State aforesaid, in consideration of four hundred Dollars to me paid by Prince Negro lad Slave, & Roger his father a man of Colour, I have bargain sold emancipated and freed, and by these presents do bargain sell emancipate & free the said Negro Prince, and I do hereby bind myself & heirs to warrant & forever defende the aforesaid negroe in his freedom against myself my heirs & assigns, and against the legal Claim of all persons whomsoever. and the said negroe Prince is hereby declared free without any Let Hindrance molestation or interruption of any person or persons whomsoever either in this State or in the United States, Given under my hand & Seal this twelfth day of July in the year of our Lord one thousand eight hundred ten, and in the thirty fifth year of the Independence of the United States of America
