of Tennessee Dixon County for and in consideration of two hundred dollars to me in
hand paid by George Rop of Greenville District in the State aforesaid, I have granted
bargained sold, and by these presents do grant bargain sell unto the said George
Rop all that tract or parcel of land, containing one hundred and twenty one acres
situate in the district of Greenville & State aforesaid, bounding on the South side of
Brushy Creek, waters of Ennee River whereas it beginning on a red oak station
on the creek from thence S. 50 to a red oak corner, thence W. 38. to a red oak
corner, from thence S. 40, E. 15. 25 to a hickory corner, thence S. 40 E. 15. 50 to post oak
corner, thence N. 70. E. 29 to a stake corner, thence S. 40 E. 2. 50 to a hickory corner,
thence S. 75 E. 3. 50 to Red corner, thence N. 31 E. 11 to sawwood corner, thence
up the said creek, to red oak corner, thence S. 68. W. 9 to stake corner, thence N. 22
W. 2 to Holley corner, from thence to S^d Rop's cherry tree corner, from thence up
the said creek to the Beginning station on the creek, Together with all singular
Rights members hereditaments & appurtenances to the said premises belonging or
in any wise incident or appertaining therunto to the only proper use & behoof
of him the said George Rop his heirs & assigns forever, & I Aaron Kemp doth hereby
bind himself his heirs Exec^{rs} & admin^{rs} to warrant and forever defend all singular
the premises above mentioned unto the said George Rop his heirs Executors, admin^{rs}
and assigns forever, against myself my heirs Exec^{rs} & admin^{rs} & against every other
person or persons whomsoever lawfully claiming or to claim the same, or any part
