



S 75 W 13-50 to a hichory 3x bounding on Thomas Hammittons lands thence S 30 E 7 to a dead
3x thence S 60 W 30 to a hichory 3x bounding on said Hammittons Lands, thence S 20 E 13-50
to the begining bounding on John Thomas lands Together with all and singular the rights
members heriditaments and appertanances to the said premises belonging or in anywise
Incident or appertaining To have and to hold all and singular the premises before mentioned
unto the said William Arnold his heirs and assigns forever and I do here by bind myself
my heirs Executors and administrators to warrant and forever defend all and singular
the said premises unto the said William Arnold his heirs and assigns against
myself and my heirs ^{and} against every person whomsoever lawfully claiming the same
