Know all men by these presents that I Thomas Brasher of the State and district aforesaid for and in consideration of the sum of four hundred and fifty dollars to me paid by George Smith of the State & district aforesaid, have granted bargained sold and released and by these presents do grant bargain sell and release unto the said George Smith a parcel or tract of land containing three hundred acres, it being a tract that was originally surveyed for said Brasher on the 9th day of February 1789 and recorded in the Location office 14th day of September 1789, Beginning on a black oak (near Baker's creek a branch of the reedy fork of reedy river) thence running S. 60 W. 20.25 to a post oak thence N 50 W. 37.50 to a Pine, thence N. 40 E. 48 to a Post oak, thence S. 20 E 53.25 to a Post oak, thence S. 50 E 35 to the beginning, including the Plantation where Tho: Brasher now lives, with three hundred acres of land, more or less, Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the said premises before mentioned unto the said George Smith his heirs and assigns forever. And I do hereby bind myself my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said George Smith his heirs and assigns against myself & my heirs and against every other person whomsoever lawfully claiming or to claim the same or any part thereof. Witness my hand and seal this fourth day of September eighteen hundred and eleven and in the thirty sixth year of the Independence of the United States of America
