Oak from thence N. 83 W. 21 to the beginning Together with all and singular the rights members hereditaments, & appurtenances to the said premises before mentioned unto the said Lemuel J. Alston his heirs & assigns for ever. & I do hereby bind myself my heirs executors and administrators to warrant & for ever defend all and singular the premises before mentioned unto the said Lemuel J. Alston his heirs and assigns, against myself and my heir, & against every person whatsoever lawfully claiming or to claim the same or any part thereof. Cray of the State and district aforesaid, I do hereby grant bargain sell and release unto the James M. Cray a parcel or tract of land containing fifty one acres being part of a tract of four hundred and ninety one acres of land conveyed by John Peak to Archibald Lester and by S. Lester to Samuel M. Cray, situate in the State and district aforesaid, on a small branch of Guilden Creek, water of the Enoree River, Beginning on a Stake on Andersons wagon road & runs N 17 E. 21. ch. to a post oak & then N. 73 W. 23 ch. to a Stake & then S 13 W. 27 to a Black oak bush on a Wagon road, then down said road to the beginning Stake. Together with all & singular the rights members hereditaments and appurtenances unto the said premises belonging, or in any wise incident or appertaining, unto the said James M. Cray his heirs and assigns for ever, & I do hereby bind myself my heirs executors administrators, or assigns to warrant & for ever defend the above described premises unto the said James M. Cray his heirs executors administrators & assigns forever, against myself my heirs executors administrators, & against every other person or persons who so ever lawfully claiming or to claim the same or any part thereof.
