

And whereas the said premises, with their appurtenances, since the seizure by me made by virtue of the said Writ of fieri facias before mentioned, have been exposed to sale at public vendue, and purchased by Colib Hughes for Adam Canuth of the district aforesaid for the sum of Forty nine dollars, he the said Adam by his friend aforesaid being the highest bidder therefor: Now know ye that I Thomas Payne Sheriff aforesaid, by virtue of the said Writ of fieri facias aforesaid to me directed, and delivered as aforesaid, and by virtue of the Statute in such case made and provided, and for an in-consideration of the said sum of Forty nine dollars aforesaid, being the highest sum bidden, to me in hand paid by the said Adam Canuth, the receipt and payment whereof I do hereby acknowledge, have granted, bargained and sold, & by these presents do grant bargain and sell unto the said Adam Canuth, his heirs & assigns for ever, the said tract piece and parcel of land with its appurtenances, and all the Estate right title and Interest which the said Lee Hoid hath or of right had of in and to the same. To have and to hold the said piece, parcel and tract of land with its appurtenances unto the said Adam Canuth his heirs and assigns for ever, as fully and absolutely as I the said Thomas Payne Sheriff as aforesaid might, could or ought to grant bargain and sell the same, by virtue of the Statute aforesaid or the said Writ of fieri facias, or otherwise. South Carolina, Know all men by these presents that I Thomas Edwards Senr. of Greenville District and State aforesaid in consideration of the sum of fifteen hundred dollars to me in hand paid by Jeremiah Wilcox of the State and district aforesaid the receipt whereof I do hereby acknowledge have granted bargained sold released conveyed and confirmed and by these presents do grant bargain sell release convey & confirm unto the said Jeremiah Wilcox his heirs and assigns all that plantation tract or parcel of land containing five hundred acres more or less situate in Greenville District on the branches of Muck Creek waters of Tyger River on the branches of Quorea River and on the branches of the north fork of Saluda River, and Runs as follows, that is to say Beginning on a stake near the Ashville
