& sixty acres to him the said John Laboon as his right and pro-  
-party in security of the payment of the above note, but if the  
said Richard Hornbuckle shall faithfully pay up the said note  
within Eleven months and six days from the date of the above  
mentioned note every thing herein mentioned is void otherwise in  
full force. Witness my Hand and seal this 19 January 1818.

for and in consideration of the sum of Fifty Dollars to me in  
hand paid by Robert Fleming of the City of Charleston and State  
aforesaid Merchant, have granted bargained sold and released  
and by these Presents do grant bargain sell and release unto  
the said Robert Fleming, all that Piece parcel or part of a  
tract of Land containing one Hundred and thirty six Acres be-  
the same more or less situate lying and being in the district &  
State aforesaid, on a branch of Richland Creek waters of Sandy River  
Beginning on a Stake corner on Crosses old line running thence S<sup>o</sup> 68<sup>o</sup>  
W 18 chs to a Stake corner thence North one ch. to a Stake thence N<sup>o</sup>  
66 E. 45 chains to a Stake corner to land granted to Johnston thence  
N<sup>o</sup> 34 W. 38 ch 50 links to a Black Oak corner thence N 45 East 15  
chains to a Dogwood thence S 30 E. 19 ch. to a Black Oak thence S<sup>o</sup>  
40 E 22 ch. 75 links to a Dogwood thence S<sup>o</sup> 15 W 20 ch 75 links to a  
Dike by old P.C. thence S<sup>o</sup> 75 West to the beginning being part of a  
tract of land originally granted to said Fowler in the year 1763  
Together with all and singular the rights members incidents and  
appurtenances whatsoever to the said premises belonging or in any  
wise incident or appertaining: to have and to hold full and  
singular the premises before mentioned unto the said Robert  
Fleming his heirs and assigns for ever
