



State of South Carolina Greenville District Know all men by  
these presents that I Serry Davis of the District of Pendleton  
State aforesaid for & in Consideration of the sum of Three  
Hundreds Dollars to me in hand paid by Amos Ladd Sutherland  
of the same State & District have Granted Bargained Sold  
& Released & by these presents do grant Bargain Sell Release  
unto the said Amos Ladd Sutherland a certain parcel or tract  
of Land containing one acre & one acres Situate in the Dis-  
trict of Greenville & State aforesaid on the south fork of Saluda  
River Beginning on the North side of said River on a white pine  
thence a Strat Line to a Maple tree thirty five degrees East and  
thirty seven chains to a Hickory thence South fifty four degrees East  
& Twenty five chains & fifty links to a White pine on the bank of  
the River thence up the Manders of the River to the beginning together  
with all & singular the Rights members hereditaments & appurten-  
ances to S<sup>r</sup>. premises belonging or in any wise incident or appur-  
taining to have & to hold all & singular the premises before man-  
mented unto the said Amos Ladd Sutherland his heirs & assigns  
forever & I do hereby bind my heirs Executors & Administrators to  
warrant & defend all & singular the S<sup>r</sup> premises unto the said  
Amos Ladd Sutherland his heirs & assigns against my self & my  
heirs & against any person whomsoever lawfully claiming or to ob-  
tain the same or any part thereof witness my hand & Seal this Tw-  
enty Eighth day of January anno Domini Eighteen Hundred & Seven  
& of the sovereignty of the United States the 34 & 35 Year witness  
present
