Edson of County State of Ohio for and in consideration of the sum of
Five Hundred Dollars to me paid by Francis Adams of the
District of Greenville and State aforesaid have Granted bargained
sold and Released and by these presents do Grant bargain sell &
Release unto the said Francis Adams a tract or parcel of Land
Laying and being in the District aforesaid on the head of the
Sunk hole fork of Sugar river beginning at a Post oak and running
thence North Eighty chain to a stake thence due West Eighty chain
to a chestnut South Eighty chain to a chestnut thence West Eighty
chain to the beginning containing by estimation Six Hundred and
Forty Acres be the same more or less the same being a tract of land
Granted to Benjamin Edson bearing date the 4th of May seventeen
Hundred & Eighty seven including the Houses where Benjamin
Davis and Hannah Belov lived together with all and singular
the rights numerous Houdetements and appertinances to the above
mentioned premises belonging or in any wise appertaining to have
& to hold all and singular the premises before mentioned unto
the said Francis Adams and I do hereby bind myself my heirs
Executors or Administrators to warrant and forever defend
all and singular the said premises unto the said Francis Adams
his heirs and assigns for ever against me and my heirs and
against every person or persons whomsoever lawfully claim-
ing or to claim the same or any part thereof in witness where-
of I have hereunto set my hand and seal this Thirtieth day
