Prof a certain Tract or parcel of land laying & being in the district aforesaid, on the South side of South Pachtolac River. Beginning at gum bush below the waggon ford of the Logans road on the South side of South Pachtolac River, on Ball's old line thence S^W with his line 34 Chains to a chestnut. Thence East 37 Chains to a Chestnut. Thence N^W 34 Chains to a pine not an old corner made for Pleasant Easty thence West 37 Chain to the beginning containing by estimation, one hundred & thirty two acres be the same more or less. The principal part of said tract known by the name of Moses Spans old plantation, originally granted to James Bates & from him to said Span & from him to John Gowen Sen^r Together with all & singular the rights, members hereditaments & appertinances to the said "premises" belonging, or in anywise appertaining. To have & to hold all & singular the said premises before mentioned unto the said Rice J. Prof for ever & we do hereby bind ourselves our heirs, Executors or Administrators to warrant and forever defend all & singular the above mentioned premises unto the said Rice J. Prof's his heirs or assigns & against our selves our heirs & against every person lawfully claiming or to claim, the same in any part thereof.
