


State of South Carolina Greenville district. Know all men by these presents That I Wm H. Cooke of the one part for the consideration of the sum of one hundred dollars to me paid by Charles Sotherlin of the other part both in the district aforesaid have granted bargained sold and released and by these presents do grant bargain sell & release unto the said Sotherlin all and singular a plantation or tract of land situate in the s^t district on both sides of Gap creek road on the head branches of Tyger and on branches of the N^o fork of Saluda river bounded on the north side by land survey for Gor. Holcombe & on the S^t side by land surveyed for John Brazil beginning at a forked chestnut & running thence S^E 50 C 10 L^W to a B.O. 3X S^S 70 E 4² to a hickory 3X N^S C 13 to a pine 3X N^E 20 E 39-50 L^W to a locus 3X N^S 54 E to a hickory 3X N^S 14 W. 17 to a chestnut 3X N^S 55 W. 25-50 to a chestnut 3X S^S 63 W 13 to a R.O. 3X S^S 10 C 14 to a white oak 3X S^S 17 E 6-50 to a hickory 3X S^S 9 W 14 to a chestnut 3X S^S 30 W 5-25 to a B. gum 3X N^S 62 W 23 to a chestnut 3X S^S 82 W 37-50 L^W to the beginning containing two hundred & ninety three acres to the same more or less. Together with all and singular the premises before mentioned unto the said Sotherlin & his heirs, executors and administrators to warrant and forever defend all and singular the said premises from myself, my heirs lawfully claiming or to claim the same or any part thereof but from no other person or persons.
