cane brake branch of Moore river. Beginning at a stake ^{running} N 20 E 60
to post oak corner thence from said post oak corner running a
conditional line to a white oak corner on said cane brake branch
thence said branch to the line up to a poplar corner thence S 72:
25 to the beginning. Together with all and singular the rights
members, hereditaments, and appurtenances to the said premises
belonging or in any wise incident or appertaining. To have & to
hold all and singular the premises before mentioned unto the
said Daniel Mayfield his heirs and assigns forever. And I do hereby
bind myself my heirs executors and assigns to warrant and forever defend
all and singular the said premises unto the said Daniel Mayfield
his heirs and assigns against myself and my heirs & against every person
whomsoever lawfully claiming or to claim the same or any part thereof
