 or to claim the same or any part thereof. Witness my hand & seal
 this 20th day of November 1813. Signed sealed & delivered in presence of us
 test Joseph Haggott; John Wolfe. Philip Chambers, Junr.

South Carolina Greenville district. personally came Jo^{seph} Haggott
 before me an acting Justice for said district & made oath in due
 form of law and said that he saw Philip Chambers sign over
 the within deed of conveyance & deliver the same to Willis Hicks
 for the use and purpose within mentioned also that he saw
 the subscribing witness with himself witness the same. Sworn
 to this 1st day of November 1814.

 George Spillars send for and in consideration of the sum of three hundred
 dollars to me in hand paid by Jeremiah Hide have granted, bargained
 sold and released & by these presents do grant, bargain, and sell unto the
 said Jeremiah Hide a plantation or tract of land lying & being
 situate, in the district and state aforesaid, on both sides of
 Maple swamp creek, waters of needy river, the land to be conveyed
 Begins on a B.O. 3x runs S 40 E 56 ch^o to a stake 3x S 50 W 51 to B.O.
 3x N 40 W 22 to B.O. 3x N 50 E 16. 50. to B. Jacks 3x N 40 W 34. 50 to
 a pine N 50 E 34. 50 to the beginning, it being a tract originally
 granted to John Gilliland & conveyed to the said Geo. Spillars
 Junr. containing two hundred and twenty seven acres by estimation.
 Together with all and singular the rights, members, hindertments,
 and appurtenances to the said premises, blonping or in any wise
 incident or appertaining. To have and to hold all and singular the
 premises before mentioned unto the said Jeremiah Hide. And I
 do here by bind myself my heirs, Exec^{rs} and adm^r to warrant & forever
 defend all & singular the premises before mentioned unto the s^d
 J. Hide against myself & my heirs & against every other person
 or persons whosoever lawfully claiming or to claim the same or any
 part thereof. In witness whereof I have hereunto set my hand and
 seal this the 1st day of April 1820. Signed, sealed & delivered in presence of us.
