187 State of South Carolina Know all men by these presents that I Allen Marshall of Greenville district and state aforesaid for & in consideration of the sum one hundred and fifty Dollars to me paid in hand by Alexander Robbs of Greenville district & state aforesaid have ^{granted} bargained sold and released unto the said Alexander Robbs ^{all} that tract or parcel of land containing one hundred and five acres be the same more or less being a part of a tract of five hundred acres originally granted to Arthur Stafford which said one hundred and five acres lies in the south west corner of said tract of five hundred acres bounded on the south by Land granted to Wm. D. Thomas on the west by land granted to Gullison and others on the north by Allen Marshall Edge on the east by Henry Cannon's land beginning on the south line of said tract on a post oak running west to the corner of said tract, thence nearly north 35 ch. fifty links to a black oak thence nearly east to a black oak thence south to the beginning corner together with all & singular the rights hereditaments & appurtenances to s. one hundred & five acres of land belonging or in any wise incident or appertaining to have & to hold all & singular the premises before mentioned unto the said Alexander Robbs his heirs and assigns for ever And I do bind myself my heirs assigns Executors & administrators to warrant & for ever defend ^{all} and singular the premises before mention against my self my heirs or assigns or any other person or persons whomsoever lawfully claiming the same or any part thereof.
