

E 8 to a stake 3x thence N 57 W 13 to a post oak 3x thence N 21 W 17. 50 to the Beginning Corner Situate & lying in the District Greenville on the South West side of the grove creek waters of Saludy River together with all and singular the rights members Hereditaments & appertanances to the said premises belonging or in any wise Incident or appertaining to have and to hold all & singular the premises before mentioned unto the s^r Samuel Williams his heirs & assigns forever & I do hereby bind my self my heirs Executors & administrators to warrant & forever defend all & singular the s^d premises unto the s^r Samuel Williams his heirs & assigns against my self & my heirs & against every other person whomsoever lawfully Claiming or to claim the same or any part thereof. as witness my hand & seal this twenty fifth day of July & in the year of our Lord one thousand eight hundred and twenty & in the forty fifth year of the Independence of the United States of America. signed sealed & delivered in the presents of Samuel Williams John ^{his} Kelly Henry ^{his} Lawley } W^m Kelly
