

The State of South Carolina. Know all men by these presents that I, Francis A. Ragsdale of Grunville District in the State aforesaid, in consideration of six hundred dollars to me paid by Edmund Ragsdale of the State and district aforesaid have, Granted bargained, sold, and released and by these presents do grant bargain sell and release unto the said Edmund Ragsdale all that plantation or tract of land containing one hundred and eighty four acres be the same more or less, situate in the district aforesaid lying on a branch of Rudy River Beginning on an oak 3x running thence N 15 W 2 90 to a red oak 3x bounding on David Traubham's land thence N 75 W 57 45 to a stake 3x bounding on the said Edmund Ragsdale and Hewlett Sullivan Jar. thence N 15 E 28 25 to a red oak 3x near the head of said branch bounding on said H. Sullivan thence down the meanders of the branch to the beginning. Together with all and singular the rights, members, hereditaments and appertinances, to the same belonging or in any wise incident or appertaining. TO HAVE AND TO HOLD all and singular the premises before mentioned unto the said Edmund Ragsdale to him and his heirs and assigns forever and I do hereby bind myself my heirs Executors and administrators to warrant and forever defend all and singular the said premises unto the said Edmund Ragsdale his heirs and assigns against ~~my~~ self and my heirs and against Every other person whomsoever lawfully claiming or to claim the same or any part thereof. - Witness my hand and seal this twelfth day of January in the Year of our Lord one thousand eight hundred and thirty and in the fifty fourth Year of the Independence of the United States of America signed sealed and delivered in the presence of
