 Ruddy River containing one hundred acres be the same more or less
 being part of a Tract of land Originally granted to John Wickley
 beginning on a Stake corner on Whites line made for Alexander Thompson
 thence on Whites line S 25 W to a corner on the same made for Aquilla
 Braasher and said Cook thence on a new line S.E. 65 made for said
 Braasher, Cook and Alexander to the corner thence N. E. 25 to a post oak
 on Alexander Thompsons line thence on said line N. 54. W to the Beginning
 To have and to hold all and singular the premises a-bore described
 unto the said Thompson his heirs and assigns for ever, and I do here by
 kind myself my heirs Executors or administrators to warrant and forever
 defend the same against me my heirs or assigns and against every
 other person lawfully claiming the same or any part thereof In
 Witness whereof I have hereunto set my hand and seal this
 third day of December in the year of our Lord one Thousand
 Eight-hundred and thirty. Signed Sealed and delivered in the
