

Cituate lying and being in the District of Greenville and State aforesaid on the head of Barton fork of Tiger River Beginning on a Rock near Charles Sutherland Land Spanish Oak corner running North fifty East to a double Chesnut a conditional corner made by the said Joseph Barton and Charles Sutherland thence up the ridge to a big rock commonly called Sutters Rock thence to a Locust standing on the top of the ridge thence to the Beginning corner it being a part of a certain tract or parcel of Land granted to the said Joseph Barton Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise incident to have and to hold the above mentioned premises unto the said Charles Sutherland his heirs and assigns forever from us and my heirs and from no other person or persons whomsoever and I do hereby bind my self my heirs Executors and administrators to quit claim the above described premises unto said Charles Sutherland his heirs or assigns and us further and it is expressly understood and the intent and meaning that I am only to warrant and forever defend the above conveyed Land from me and my heirs unto the said Charles Sutherland and his heirs and assigns and no further In Witness whereof I have hereunto set my hand seal this sixth day of November one thousand Eight hundred and twenty four Signed sealed and delivered in presence of us
