 to the same (beginning) on the Western Nelson corner at the creek on Moon's line
 running with Moon's line to a post oak corner, thence running with lands line to
 the creek to a Stake corner on Enorce, thence down the South fork of the River
 to the Beginning) Together with all and singular the rights members hereunto
 appurtenances to the premises belonging) or in any wise incident or appur-
 tainings) To have and to hold all and singular the premises above mentioned unto
 said Samuel Barnett his heirs and assigns forever and I do hereby bind myself
 my heirs Executors and Administrators to warrant and for ever defend the premises
 mentioned unto the said Samuel Barnett and his heirs against myself my heirs
 Executors and Administrators and against all and every other person or persons lawfully
 claiming) or to claim the same or any part thereof In Witness whereof I have
 hereunto set my hand and fixed my seal this 25th day of Sept. 1837 David Barnett

 South Carolina, John Barnett made oath before me the subscribing Justice of the
 Greenville District) he saw David Barnett read sign seal and deliver the within
 deed to Samuel Barnett for the uses and purposes therein mentioned and that said
