I, William M. Goodlett, Sheriff
of Greenville District, and State aforesaid, send
Greeting: Whereas, by virtue of a Writ of Fieri
Facias, issued out of the Court of Common

Pleas, held for the District of Greenville, tested the seventeenth
day of April in the year of our Lord one thousand eight hundred
and forty-three at the suit of Sidon Moon, to me directed,
commanding me, that of the goods and chattels, lands and ten-
