And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend, all and singular the said Premises, unto the said Sabey Gilreath, his Heirs and Assigns, against me and my Heirs, and against every person whomsoever, lawfully claiming or to claim the same or any part thereof. Beginning on Stathe 3 x 0. m. or thence N. 27^{1/2} E. 3^{1/2} chains to Hickory thence N. 89^{1/2} E. 20.46 chains to Red oak 3 x 0. m. on Road leading from Estab.
