This Indenture, made the seventeenth day of July in the year of our Lord one thousand eight hundred and forty-four between J. A. Leland, Superintendent of Public Works of the State aforesaid, of the one part, and James H. Cleveland, of the other part: Whereas, The said James H. Cleveland stands indebted to the said John A. Leland, Superintendent as aforesaid by Bond for the sum of Nine Dollars and Eighty-seven Cents payable in three annual instalments, with interest from the date thereof, That is to say, one third part with interest, on the seventeenth day of July, 1845, one other third part, with interest, on the seventeenth day of July, 1846, and the remaining third part, with interest, on the seventeenth day of July, 1847.
