Smith, of the State and District aforesaid did several years ago sell to John Ford of said State and District (now Dec ^d .) a Tract of Land laying in the State and District aforesaid on the head branches of the Cedar Shoal Branch waters of Reedy River and give him a bond to make titles to the same, the said John Ford now being dead, the Heirs and administrator of his Estate requests me to take up the bond and make titles to Willis Chand- ler + Micajah Perry, as they have sold them the Land, to enable the administrator to pay the Debts of the Estate, now in consider- ation of the said Willis Chandler in hand paying one hundred and twenty four Dollars, I have granted, bargained sold and released and by these presents do grant bargain sell and release unto the said Wil- lis Chandler part of said Tract of land being the part that my Father Alexander Smith bought from George Brooks for sixty acres except eight acres that lays on the west side of the road leading from the Lick to Punklers Bridge on Reedy River, that S. P. Mc- Perry gets beginning at a stone 3x on a line of the land said Chand- ler bought from Charles Perry thence S 75 E 39.35 to a Red oak stem 3x on the Road thence N. 55 W. about 20 ch. to bend in the said road thence still along said Road about 20 ch. to the North line thence N. 75 E. 10 to a stake thence S. 55 E. 40 50 to the Beginning containing fifty four acres in the same more or less, Together with all and singular the rights members hereditaments and appurtenances to the said Premises belonging or in anywise incident or appertaining - to have and to hold all and sin- gular the said Premises unto the said Willis Chandler his Heirs and assigns forever.
