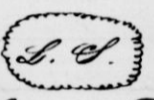

O. stump 3x & pointers thence N. 80 W. 20 ch. to a stake 3x thence S. 31 W. 1 ch. to stake 3x thence N. 80 W. 21 ch. to a stake 3x thence N. 31 E. 1 ch. to a stake 3x thence N. 80 W. 17 ch. to a stake 3x originally P.
