he directed his Executor to sell for distribution among his heirs &c. Now Know all men by these presents that I James T. Lovelass Executor of James Lovelass Dec^d. in consideration of seven hundred and twenty dollars to me paid by Joseph Sullivan of same District & State aforesaid, have granted, bargained, sold and released and by these presents do bargain sell and release unto the said Joseph Sullivan a plantation or tract of land containing Two hundred & fifty acres (more or less) situate in Greenville District, lying on the branches of Horse Creek waters of Reedy River beginning on a Red Oak 3x binding on Martin Arnold's land running thence N. 39 W 37.50 to a Red Oak 3x thence S 48 W 65.30 to a Sassafras 3x binding on Joseph McCullough's land, thence S 40 E. 44.00 binding on Elizabeth Gains land to a stake 3x on a Branch, thence down the meanders of said Branch to the beginning corner.

Together with all and singular the rights members here- ditaments and appurtenances to the said premises belonging or in any wise incident or appertaining to have and to hold all and singular the premises before mentioned unto the said Joseph Sul- livan his heirs and assigns for ever, and I do hereby bind my- self my heirs, Ex^{rs} and Adm^{rs}. to warrant and forever defend all and singular the said premises unto the said Joseph Sullivan his heirs and assigns against myself & against my heirs and a- gainst any other person whatsoever lawfully claiming or to claim the same or any part thereof.
