Know all men by these presents that  
I, Jeffer P. Poole of the District of Greenville  
and State aforesaid for and in consideration

of the sum of Five hundred dollars as also all my stock horse-  
hold and kitchen furniture & farmers tools to be discharged by Green  
P. Poole of the district and state aforesaid, comfortably maintaining  
myself and my wife, Tobias, during our natural lives (we  
remaining with him) all that tract or parcel of Land contain-  
ing Eighty acres be the same more or less situated in Green-  
ville district on the north side of Enoree River beginning at the  
River on Gilbeath's line thence along Gilbeath's line to a pine stump  
nearly the same course to Henry Parbys line to a Post Oak  
thence S<sup>o</sup> 12<sup>o</sup> E. thirty three chains fifty links to a White Oak  
thence South 8<sup>o</sup> W. 30 chains to a dog wood on the bank of said  
River thence up said River to the beginning, also all that tract  
a parcel of land bought of John Pike adjoining the same  
containing twenty acres Beginning on a stake on Henry Parbys  
line an East course to a Chestnut thence South to a Spanish oak  
thence a strait line to a White Oak stub, thence to the beginning  
Together with all & singular the rights members hereditaments and ap-  
purtenances to the said premises belonging or any wise incident or
