I know all men by these presents that I Margaret B. Macher of the District of Greenville in the State aforesaid, for and in consideration of the sum of Thirteen Hundred and Twenty Three dollars \$1300 to me in hand paid by Mary W. Lewis of the State of Georgia Cherokee County, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Mary W. Lewis all that Tract or Parcel of Land parts originally granted to Henry Macher and Jesse Moody and now the residence of the s<sup>d</sup>. Margaret B. Macher containing by survey one hundred & twenty six acres, be the same more or less having such bounds marks &c as follows viz. Beginning at a stone Corner on Jeremiah Cleavelands line thence along the front line N. 83 E. 53. 50 lks. to a stone Corner thence S. 54 E. 22. 25 lks. to a stone x 111 on Cleavelands line thence S. 21. W 10 lks to a stone on the branch thence down the meanders of the branch to a stone x 111 on the lower end of a ditch, on Cleavelands line thence along said line N. 59 W. 46. 25 to a pine Corner thence N. 50 E. 16 lks to a stone x 111 thence N. 27 1/2 W. 90 links to the beginning which s<sup>d</sup>. lands are parts of Grants made to Henry Macher and Jesse Moody as aforesaid - said Margaret B. Macher reserving one acre around the grave yard which is reserved as a family Burying ground.

Together with all and singular the Rights, Members, Accretions and Appurtenances to the said Premises belonging, or in anywise incident or appertaining: To have and to hold, all and singular the Premises before-mentioned, unto the said Mary W. Lewis her Heirs and Assigns forever. And I do hereby bind myself my Heirs, Executors and Administrators, to warrant and forever defend, all and singular the said Premises, unto the said Mary W. Lewis her Heirs and Assigns, against myself and my Heirs, and against every person whomsoever, lawfully claiming or to claim the same, or any part thereof.
