Wilson	David 150 Dores	408 South Carolina } Greenville District } now by these presents that I John Cooper of the District and State aforesaid for and in consideration of the sum of Three Hundred and twelve Dollars to me in hand paid by Reuben C. Wil- son of the same State and district from granted, bargained sold and released and by these presents do grant, bargain sell and release unto the said Reuben C. Wilson a certain tract of Land situated in said District on waters of Saluda River near old Salmon Meeting House containing One Hundred and fifty Acres it being part of a tract of Land originally granted to James Blasingame it being also a part of the same tract of land containing Two hundred and forty seven Acres of a survey which was carried to me by the Revd W. B. Johnson and hath such bounds marks &c as follows by beginning at a Blk Gum 3x on Paynes Mill creek thence N 69° W 2 chs to a Red oak 3x thence N 21° E 10 chains to a Stake 3x thence S 63° W 56 chs to a small P. O. bush 3x on what is called Qualls line thence with said line S 69° E. 8.50 chs to a Red oak 3x thence S 13° E 13 chs to a Stone 3x thence S 3° W 21.50 chs to a Poplar 3x at the head of a branch thence down the meanders of said branch to a Sassafras 3x near its junction with the meeting house branch thence up the meeting house branch about 60 ft to a black oak 3x thence N 39° E 16.80 chs to a Blk Oak 3x thence N 57° E 16.50 chs to a White Oak 3x on said Paynes Mill creek thence up the said meanders of said branch to the beginning corner together with all and singular the rights, members benefits -ments, and appurtenances to the said premises belonging or in anywise incident or appur- tenant to them and to hold all and singular the premises aforesaid unto the said Reuben C. Wilson his heirs and assigns forever
