that at least seven days previous to this examination she did actually join her husband  
- and in a deed of Attorney to Shanton P. Pool authorizing and empowering him  
to sell and convey three certain Tracts of Land in Greenville District South Carolina  
of which John P. Pool deceased late of Greenville District South Carolina did  
seize and possess consisting of First The Home Tract supposed to contain about  
One Hundred and Twenty five acres Second The Fox Branch Tract containing  
Three Hundred and thirty five acres more or less Third The Packhill Tract contain-  
ing One Hundred and sixty Acres more or less and that she did at the time of  
the execution of the said Deed of Attorney and still does freely voluntarily and without  
any manner of compulsion deed or fear of any person or persons whatsoever renounce  
release and forever relinquish all her estate interest and inheritance in the said  
tracts of Land unto the grantee or grantees of the said Shanton P. Pool by virtue  
of said Deed of Attorney and their heirs and assigns And the said Elizabeth Sandwith  
doth further declare that the said Deed of Attorney was positively and bona fide  
executed at least seven days before this examination
