Stephen P Phillips	499 82 Acres	South Carolina Known all men by these Greenville District presents that I Oliver P Phillips of the District and State aforesaid for and in consideration of the sum of Two hundred and seventy five dollars to me paid by Stephen P Phillips of the same State and district have granted bargained sold and released and by these presents do grant, bargain and sell and release unto the said Stephen P Phillips a certain tract of Land containing eighty two acres by the same more or less situated in said district on the waters of Studly Creek it being three small tracts of land two of which was conveyed to the said Stephen P Phillips by Jeremiah Cleveland by deed bearing date the third day of November one thousand eight hundred and thirty four and the other conveyed to the said Stephen P Phillips by Penkney Hawkins the 2 ^d dy of January 1836. The whole having such bounds, marks &c as follows

To have and to hold all and singular the rights, member hereditaments and appurtenances to the said premises belonging to or in any wise incident or appertaining To have and to hold all and singular the premises aforesaid unto the said Stephen P Phillips his heirs and assigns forever And I do hereby bind myself my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said Stephen P Phillips his heirs and assigns against all and my heirs and against every person whomsoever lawfully claiming a to claim the same or any part thereof.
