 Slaves or real Estate and the Trustee approve of such exchange he in that
 case is hereby empowered to sell and make titles to the said negroes sold
 and the proceeds so sold thereof to be laid out in other Slaves or real
 estate and the Slaves so purchased or real Estate are to be held in Trust in
 the same manner as the above named Slaves and to be disposed of at her
 death in the same manner also. And the said Slaves and the child
 are to be estimated and valued at Six Hundred and Fifty Dollars and such
 my said daughter Elizabeth equitable share of my estate either under
 my will or an administration
