

of the sum of One Hundred Dollars to me in hand paid have given sold and released  
and do by these presents give sell and release unto the said Wm H. Goodlitt the tract  
of Land and plantation wherein he now lives lying on the west side of South Tiger  
River Beginning at the mouth of a creek the line between said land and land belong-  
ing to William Dickey Thence up said creek following the main ditch to a mistle  
at the mouth of a small branch which comes into said creek from the south Thence  
up said branch to a Black Oak at the head of the swamp Thence S 31 E 22 chains  
to a Stake Thence to a Poplar at the head of a branch on James Woods line  
Thence down the meanders of the branch to the river Thence up the river to the beginning  
Reference being had to my several deeds and plat for the same. This being half of  
all my tract of land lying on both sides of said river. The east side having hitherto  
been given to my daughter Mary H. Ballinger. Supposed to contain about two  
hundred and thirty acres.

Together with all and singular the rights members and  
appurtenances to the said premises belonging To have and to hold all and singular
