




State of Georgia I William Lytle one of the Commissioners appointed in

 quish all his Estate interest and inheritance in the within premises mentioned

 containing about One Hundred acres bounded by Lands of William E. Worklife
 Daniel Pike and James Hooker having such boundaries courses &c as may
 be had by reference to a plat survey of the same as the plat herunto annexed

Together with all and singular the Rights Members Members-
 -ents and Appurtenances to the said premises, belonging or in anywise incident or
 appertaining To have and to hold all and singular the Premises before mentioned
 unto the said W. H. Hedcumber his Heirs and assigns forever And I do hereby
 bind myself Heirs Executors and Administrators to warrant and forever defend
 all and singular the said Premises unto the said W. H. Hedcumber his Heirs
 and assigns against me and my Heirs and against every person whomsoever
 lawfully claiming or to claim the same as any part thereof
