witnesseth that I Mary M'Carroll of the District and State aforesaid of the first part
and in consideration of the rights and privileges of abiding remaining and freely
enjoying and freely using the entire Tract of Land of which my late Husband
M'Carroll dec'd seized and possessed, known as the Home place for and dur-
ing my natural life, have relinquished transferred assigned and set over and by
this presents do fully and absolutely relinquish transfer assigned and set over unto
Montgomery, William West and G. W. M'Carroll all of my interest right title
claim to my distributive share of the purchase money and proceeds of the sale
of the Lands of my late Husband Samuel M'Carroll sold by the Commissioners of
the District aforesaid on Saturday in September 1851 to the aforesaid par-
ties as their own property absolutely and forever

So have and to have my aforesaid distributive share
of said Lands with the said G. C. Montgomery, William West and G. W. M'Carroll
to have their and appears given unto I do hereby bind myself my heirs
executors and administrators to warrant and defend all and singular
rights title and interest and claim to said distributive share in said Land
of the said G. C. Montgomery, William West and G. W. M'Carroll and their heirs
against every person lawfully claiming or to claim the same or any part thereof

And we G. C. Montgomery, William West and G. W. M'Carroll
of the second part for and in consideration of the foregoing relinquishment trans-
fer and assignment of Mary M'Carroll do hereby give grant bargain and
sell assign and set over unto the aforesaid Mary M'Carroll the right and privilege
remaining or freely occupying and freely using the entire Home tract aforesaid
and during the natural life of the said Mary M'Carroll who we have ourselves
her executors and administrators to warrant and defend said right and privilege
of the aforesaid Mary M'Carroll for and during her natural life
