J. Gifford to A. C. Burgess thence with said Lot S 89 E 384 feet to West D Longs land thence with said Land S 2 E to Robert McKay and N 4 S 9 Crofts line thence with said N 4 S 9 Crofts line to the beginning being the same Lot of Land conveyed by C. J.
