South Carolina Greenville District Know all men by these presents that I Miles Garrett of the State and District aforesaid that for and in consideration to me in hand of the sum of Twenty seven hundred and fifty Dollars paid by Mathew McCrary of the State and District aforesaid I have bargained and sold and by these presents do grant bargain sell release and relinquish unto the said Mathew McCrary the following Lands viz one tract of Land deeded by Nathan Davis and Jesse Hammett Exrs of Jonathan Davis lying on Durbins Creek waters beginning at a Black 3+3+ on John Garretts line thence on Miles Garretts line N 84 1/2 E 18.60 to a Stake 3+ thence N 19 1/2 W 31.50 to a Stake 3+ thence on W. B. Jones line S 49 W 11.75 to P.O. 3+ thence N 40 1/2 W 4.50 to a P.O. Bush 3+3+ thence on a dividing line of said Walk tract between Miles Garrett and John Garrett S 19 W 13.90 to a B.O. 3+3+ near a branch thence on said dividing line S 30 E 16.50 to the beginning containing fifty two acres more or less.
