Caroline Huff to John W Grady	301 page	The State of South Carolina This indenture made the twenty ninth day of January in the year of our Lord one thousand eight hundred and fifty nine between Caroline Huff of the one part and John W Grady of the other part witnesseth whereas the said Caroline Huff is indebted to the said John W Grady in the sum of three hundred dollars by two seal notes each for the sum of one hundred and fifty dollars both drawing interest from date and both bearing date the 29 th day of January A.D. 1859 one of them due twelve months after date and the other of said notes due two years after date Now this indenture witnesseth that the said Caroline Huff for and in consideration of the premises aforesaid and also in consideration of the sum of five dollars to the said Caroline Huff by the said John W Grady in hand paid at and before the sealing of these presents have granted bargained sold and released and by these presents do grant bargain sell and release unto the said John W Grady all that tract of Land containing fifty Acres more or less and being in the District of Greenville on the Laurens Road nine miles from Greenville Court House and adjoining Lands of John Smith and William McMahon. Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining to have and to hold all and singular the premises before mentioned unto the said John W Grady and to his heirs and assigns forever and I do hereby bind my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said John W Grady and to his heirs and assigns against me and my
