 of Greenville in the aforesaid State
 in consideration of Two hundred and fifty Dollars \$250 to me
 paid by Peter H Sudduth of Greenville Village in the State aforesaid
 said have granted bargained sold and released and by these
 presents do grant bargain sell and release unto the said
 Peter H Sudduth a certain tract or parcel of land situate
 lying and being in the District of Greenville and State aforesaid
 Beginning at a stake 3 1/2 m on the North side of the Casby
 Bridge Road 42 feet from Moses Parrises corner and 15 feet from
 the center of the road and runs thence North 3 3/4 W 12 chains 52 links
 to a small pine 3 1/2 m thence North 50 45 E 8 chains 50 links to a stake
 3 1/2 m thence S 3 1/4 E 11 chains 88 links crossing a small branch to a
 stake 3 1/2 m 15 feet from the center of the aforesaid road thence
 up said road 15 feet from the center South 48 W 2 chains 3 links
 to a bend in said road thence South 49 W 15 feet from the center of the
 road 6 chains 60 links to the beginning corner 15 feet from the center of the
 road opposite Parrises corner containing by estimation Ten acres (10
 acres be the same more or less) together with all and singular
 the rights members hereditaments and appurtenances to the said prem-
 ises belonging or in any wise incident or appertaining. To have and

 assigns and all other persons claiming the same or any part

 I John W Hudson of Greenville District
 and in the State aforesaid for and in consideration of the sum of
 seven hundred dollars to me paid by James L Hudson of Greenville
 District in the State aforesaid have granted bargained sold and
 released and by these presents do grant bargain sell and release
 unto the said James L Hudson all that tract or parcel of land lying
 and being in Greenville District and State aforesaid on the waters
 of Crooker River on a branch of Rocky Creek containing one hundred
 acres more or less, beginning on a black oak down near a stake
 on the original line near Silmon Rosses thence S 12 W 23 chains to a
 stake corner thence S 45 E 60 L to a stake thence N 66 E 15 ch
 40 links to a red oak with Pleasant W Hudsons Land thence
 S 23 E 20 ch 75 links to a stake with said Hudsons land thence
 N 60 E 21 chs to a stake near the head of a branch Hudsons,
 thence N 55 W 11 chs to a stake with W Hudsons Land thence
 N 85 E 27 chs 13 links with said W Hudsons Land to a stake
 thence N 67 W 17 chs 20 links with R Vaughns Land to a stake
 thence S 55 W 30 chs to the beginning black oak corner (down)
