

Robt McKay 09.0 Deed State of South Carolina  
 To For Greenville District  
 Wm Watson & Powell Land this Indenture made this sixth  
 day of August in the year of  
 our Lord one thousand eight hundred and sixty between  
 Robert McKay Ordinary of the District aforesaid, and  
 Wm Watson and Edward Powell of the same State and  
 District. Whereas a writ of summons to divide or sell a  
 certain tract of land hereinafter described of the Estate  
 of David Snowden of said District deceased issued  
 from the Court of Ordinary of said District and upon  
 the return thereof the Judges of said Court did determine  
 that the said Land could not be divided without  
 injury to the parties interested, and did order the  
 same to be sold by the Sheriff of the District aforesaid, on a  
 credit of twelve months with interest from the day of sale  
 when upon the Sheriff aforesaid did advertise the said  
 Land for sale on the first Monday in August in the  
 year above mentioned, and whereas the Sheriff aforesaid  
 did, on the said day, expose to sale, at public outcry  
 on the credit aforesaid the said Land when the said Wm  
 Watson and E Powell was the last and highest bidder to  
 whom the said Land was struck off for the sum of three  
 hundred Dollars. Now this Indenture witnesseth that  
 in consideration of the sum of three hundred Dollars to me  
 paid and secured to be paid I have granted bargained  
 sold and released, and by these presents do grant bargain  
 sell and release unto the said Wm Watson and E Powell  
 and their heirs and assigns forever all that tract of  
 Land situated in said District on waters of Saluda River  
 bounded by lands of J. C. Carson N. A. Heaster and others  
 and containing one hundred acres more or less  
 together with all the appurtenances thereto belonging  
 and all the estate right title interest claim or demand  
 which the said David Snowden deceased at the time of  
 his death had in or to the same, to have and hold  
 the said tract of Land together with all and singular  
 the premises improvements and appurtenances to the said  
 Wm Watson & E Powell their heirs and assigns forever  
 In witness whereof I the said Robert McKay as ordinary  
 aforesaid have hereunto set my hand and seal of office  
 the day and year above written, signed sealed & delivered  
 in the presence of  
 Wm Campbell W. A. McDaniel

 To For Know all men by these presents  
 Thomas C Gower Land that I John W Pickett of Greenville  
 District in the State aforesaid in  
 consideration of two thousand and twenty five Dollars  
 to me paid by Thomas C Gower of Greenville District in  
 the State aforesaid have granted bargained sold and  
 released and by these presents do grant bargain sell  
 and release unto the said Thomas C Gower all that  
 piece parcel and tract of land containing two hun  
 dred and two and one half acres more or less known  
 as No 79. in 18th District situate lying and being in the  
 State of Georgia in the County of Webster, being the  
 same tract of land conveyed by Jephtha B Pickett to  
 James Pickett by deed of February 13th AD 1843, and  
 devised by the said James Pickett to me by his last  
 will and testament, together with all and singular  
 the rights members hereditaments and appurtenances  
 to the said premises belonging or in anywise incident  
 or appertaining, to have and to hold all and singular the  
 premises before mentioned unto the said Thomas C Gower his  
 heirs and assigns forever, and I do hereby bind myself my heirs  
 executors and administrators to warrant and forever defend all  
 and singular the said premises unto the said Thomas C Gower  
 his heirs and assigns against me and my heirs, and every  
 other person whomsoever lawfully claiming or to claim the  
 same or any part thereof

 the year of our Lord one thousand eight hundred and  
 sixty and in the 85th year of the Independence of the United  
 States of America
