 honorable Court aforesaid came on to be heard on the third day
 of February in the year of our Lord one thousand eight hundred
 and seventy when the said Court after full hearing thereof and
 mature deliberation in the premises did order adjudge and
 decree that the said Real Estate should be sold at Public Auction
 by the Sheriff of Greenville County South Carolina on the terms
