of South Rabun Creek waters of Reedy River - bounded  
by lands of J H Steuhouse, Robert Bryson and J M  
Peden and being in Fairview Township State and County  
aforesaid Beginning at a R Oak 3x on Neelys Ferry  
Road thence S 82 1/2 W 2.50 to a stone 3x thence S 10 W  
3.70 to a stone 3x thence N 85 W 6.30 to a stone 3x  
thence S 11.35 to Fork Shoals Road stone 3x thence along  
said Road to a stone at Neelys Ferry Road thence Road  
line to the beginning R Oak corner containing  
fourteen acres more or less Together with all and  
singular the rights members hereditaments and  
appurtenances to the said premises belonging or in
