Junior tract containing thirty two acres more
or less bounded as follows beginning on a
Benj. Pruitts bro Corner thence S 42 E to State
and Road of J. Garris Corner thence with Garris
line to Provision or Road on the Road thence
with said Garris line to dead Red Oak or
was on the original line thence S 42 W to
my field thence along a ditch to Black Gum
thence to the beginning corner adjoining
