Howard a certain tract piece or parcel of land situated in the State of North Carolina and in the County of Greenville on the waters of North Fork of Saluda River containing one hundred acres, more or less; Beginning on a Beach on the Lind Cove Creek nearly S. to a white oak, thence nearly S. W. to a double chestnut, thence nearly S. W. to a poplar, thence a conditional line between Angeline Burrell and James Lindsey nearly E. to a stake on the head of a branch, thence down said branch to a stake at the mouth of said branch, thence nearly E. with a dead oak onto the old grant for the land, thence nearly N. to a stake on the branch, then down said branch nearly N. W. to the Beginning Beach,
