Danforth* (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said *James A. Danforth* all that piece parcel or tract

of Land Situate in the County and State aforesaid in parcel separate of Rudy River containing thirty four and one half (34 1/2) acres more or less, and having first made known to the said *James A. Danforth* as follows: Beginning on a stone 34 1/2, thence N 85 E 10 S, or to a stone 34 1/2, thence N 61 3/4 W 15, 70 to a stone 34 1/2, thence R 27 E 19, 80 to a stone 34 1/2, thence N 62 1/2 E, 19, 80 to the beginning. Bounded by lands of *J. A. Daniel* estate *Henry Schriener*, and *James A. Danforth*, being the same conveyed to me by *George A. Danforth* by deed bearing date the 14th of December 1880, and recorded on Book *X. Y. page 298*
