 Twenty seven and one tenth acres, and hath such boundaries,
 bounds, marks &c as follows: viz, Beginning at a stone 3x and
 running thence N. 8 $\frac{1}{4}$ E. 2.04 to a bend in the road, thence
 N. 57 $\frac{1}{2}$ E. along the said road 1.54 to a stone, 3x thence S. 23 $\frac{1}{2}$ E. 4.47.45
 to a stone, thence S. 8 $\frac{1}{2}$ E. 10.00 to a stone, thence S. 3-6 42.41
