Donald, my thence running in a North west direction about 600 feet to the line of Capt. George, St. Marshall. Said piece or strip of land being used in a change made in the extension of High land Avenue out side of the City limits and is feet wide for said entire distance and is to be used by Greenville County as a right of way.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said Greenville County, its successors Heirs and Assigns forever.

And I do hereby bind myself & my Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said Greenville County, its successors

Heirs and Assigns, against me and my Heirs, and every person whomsoever lawfully claiming or to claim the same or any part thereof.
