Now, Therefore, Know all men by these Presents, That we R. G. Wallace, M. B. Crisp, M. M. Teague, C. L. Fuller and W. B. Workman, Trustees of the Wadesworthville Poor School of Laurens County, in the State of aforesaid, for and in consideration

of the sum of Six 25/100 Dollars, to us in hand paid and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do Grant, bargain, sell and release, unto Ann Chick her heirs and assigns forever, all that piece, parcel or lot of land, situate, lying and being in the County of Greenville and State aforesaid on the head waters of Richland Creek of Reedy River, containing one half Acre more or less and hath such marks, bounds &c as follows viz: Beginning on a stone 3x4 Thence S 4 1/4 E 3.17 to a stone 3x4 Thence S 24 3/4 W 1.64 to a stone 3x4 Thence S 46 1/4 W 3.20 to a stone 3x0, Thence S 24 3/4 E 1.63 to the beginning corner, Bounded by lands of S. Phillips, Samuel Hill, Stephen Brown and, Thomas Clyde.
